

**APPLICATION FOR TEMPORARY CAMPGROUND PERMIT
MEADE COUNTY ORDINANCE 21**

Application for any temporary campground shall be submitted in writing to the Meade County Equalization and Planning Office at least 90 days prior to campground operation. A separate permit shall be required for each non-contiguous location. Temporary campground permits shall be obtained for each 14-day period. Notification of application will be heard at a public hearing before the Meade County Commission no less than 60 days prior to the first day of campground operation.

- An aerial photo/sketch plan must be attached showing all amenities: bathrooms, showers, drinking water outlets, light poles, fire protection devices, stage areas, concession areas, vendors, roads, etc, including all entrances and exits.
